We have determined either that the signature you provided on your vote-by-mail ballot identification envelope does not compare with the signatures(s) on file in your voter record, **OR** that you did not sign your ballot identification envelope. To ensure that your vote-by-mail ballot will be counted, this completed Statement **must be received by our office as soon as possible, but no later than 5:00 p.m. two days prior to certification of the election.** You must sign your name where specified below and include your address.

- Drop off your signed statement at the ballot drop box on Election Day only!** You may drop off your Verification Signature Statement at the ballot drop box located at the **Loyalton City Hall Auditorium**, 605 School Street, before the close of polls (8:00 p.m.) on Election Day, **November 4, 2025.**
- Come to the Registrar of Voters' Office in person.** You may come to our office at the address below, Monday through Friday 9:00 a.m. to 12:00 p.m. and 1:00 p.m. to 4:00 p.m. to return the Signature Verification Statement. This must be received by our office by **5:00 p.m. on November 30, 2025*.** **A drop box will be available at the Courthouse, 100 Courthouse Square, Downieville, CA, beginning Friday, November 28th (County Holiday) through November 30th from 8:00 a.m. – 5:00 p.m.**
- Mail your signed statement to our office in the enclosed postage-paid envelope.** The Signature Verification Statement must be received by our office at the address below by **5:00 p.m. on November 30, 2025*.** Postmarks will not be accepted.
- Fax the signed statement to our office.** Your faxed statement **must be received by our office by 5:00 p.m. on November 30, 2025*.** The Vote by Mail fax number is (530) 289-2830.
- Email the signed statement to our office.** Your emailed statement **must be received by our office by 5:00 p.m. on November 30, 2025*.** The email address is clerk-recorder@sierracounty.ca.gov.
- Please note that the signature provided on the completed Statement may be added to your registration record to be used for signature comparison purposes in future elections.

*** November 30th falls on a Sunday, therefore the deadline does not roll over to Monday, December 1, 2025.**

SIGNATURE VERIFICATION AND UNSIGNED IDENTIFICATION ENVELOPE STATEMENT

I, _____ (please print), am a registered voter of Sierra County, State of California. I declare under penalty of perjury that I received and returned a vote-by-mail ballot and that I have not and will not vote more than one ballot in this election. I am a resident of the precinct in which I have voted, and I am the person whose name appears on the vote-by-mail ballot envelope. I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years. I understand that my failure to sign this statement means that my vote by mail ballot will be invalidated.
